INVITED CORE METHODS

In March, 2003, the “Satisfaction With Decision” questionnaire was adopted as a core evaluation tool in UK program evaluation. The Satisfaction with Decision questionnaire (Holmes-Rovner M, Kroll J, Schmitt N, Rovner D, Breer L, Rothert M, Padonu G, Talarczyk G. Patient satisfaction with health care decisions: (The SWD scale). Med Decis Making. 1996;16(1):58-64.) was included in an evaluation toolkit the Medicines Partnership programme <http://www.concordance.org/projects/resources>. Last accessed, June, 2003.

The Medicines Partnership is a two-year initiative supported by the Department of Health in the United Kingdom which is aimed at encouraging patients and health professionals to work as partners in order to reach an agreement about illness and treatment. One of the objectives of the programme is to provide support to people running projects in the area of medicines partnership. The goal of the Task Force on Medicines Partnership is to support the implementation of medicines concordance into practice. It wants to demonstrate how medicines partnership can work in practice by:

- **Identifying existing projects** and supporting them
- **Facilitating new projects** in high priority areas, where there is the greatest potential for learning
- **Sharing project results** with Practitioners, managers and policy makers.

Part of the support provided to project organizers includes an evaluation toolkit to help them think about how best to evaluate their projects. The toolkit is available to them in both a downloadable and hard copy format. It includes copies of well designed relevant measures in the toolkit so that project organisers can adapt and use them to assess their projects. In including the SWD in the toolkit, the organizers indicated that, “We would like to include the Satisfaction with Decision questionnaire in the toolkit as it is one of the best, and most easy to use, measures of patient satisfaction with decision-making.”

Shared Decision-Making Forum

A founder of the Forum, (funded by the Nuffield Trust), a UK/North American “Think Tank” for the purpose of developing Shared Decision Making in Health Care. In the first year, overall objectives were:

- I. To summarize the contemporary state of the art in theory and practice of shared decision-making
- II. To develop a strategy for educating the next generation of researchers in shared decision-making
- III. To engage policy makers in the UK, the US and Canada in articulating the appropriate policy response to shared decision-making.

Objectives were accomplished in the form of numerous publications, the establishing of an electronic communication forum, and the Oxford Shared Decision-making Summer School. The work of the forum continues by means of a biennial meeting, the International Shared Decision Making meeting (Oxford 2001, Swansea Wales 2003, Ottawa 2005, Freiburg DRG 2007, Boston 2009), and the Shared-L Listserv hosted and managed from Michigan State University.

Shared Decision-Making in Health Care Summer School

One of the developers of a three-day international summer school held for the first time in July, 2001, at St. Catherine's College, Oxford. This international gathering of researchers and clinicians grew out collaboration during the sabbatical of Dr. Holmes-Rovner, Dr. Hilary Llewelyn-Thomas, Dr. Annette O'Connor, and Dr. David Rovner at the Picker Institute Europe and the Institute for Health Sciences in Oxford, January-July, 2000. The objectives of the newly established annual event are to 1) improve methods to engage patients in informed decision-making and 2) teach physicians and nurses shared decision-making skills. Participants at the inaugural session in 2001 came from the US, Canada, Wales, England, Scotland, Denmark, France, Germany, Italy, and Switzerland.

CONSUMER EDUCATION

MSU Patient Engagement Course: Getting the most from your doctor visit. ©

This course is designed for all health care consumers to teach the patient side of communication skills in the patient/physician encounter. The course is modeled after similar courses and workshops taught to medical students, and to health care professionals at professional meetings. Participants learn the structure of a clinical encounter and what the doctor is thinking when s/he asks questions about symptoms and medical history. "Role plays" allow participants to practice the best way to get all their concerns addressed in a brief doctor visit. Ways to prepare for a doctor visit and things to do after the visit are also presented. The course has been taught to Medicaid patients in a three-session course, with three hours per session, and as an offering of the MSU Evening College as one three-hour course.

MICHIGAN STATE UNIVERSITY COLLEGE OF HUMAN MEDICINE

MSU Virtual Practice ©

Information Management Theme in the College of Human Medicine 4 year medical school curriculum. Wrote original concept paper and organized faculty who began in 2001 to develop a new infrastructure for health professions curriculum innovation at MSU. The Virtual Practice is:

- a cross-college educational and research initiative developing a teaching electronic medical record (EMR), to merge practice and education in health professions education
- a virtual "laboratory" infrastructure for educational and research projects
- an opportunity for MSU to enhance its national leadership in educational innovation, distance learning technologies, outreach, and public service.

Development of the MSU Virtual Practice is being done within existing courses in the Colleges of Human Medicine, Osteopathic Medicine, and Nursing.

PCRnet, the Primary Care Research network.

Founded the Network with Mindy Smith, MD, Henry Barry, MD, and others in 1995. It evolved, joined GRIN, the Great Lakes Research Into Practice network in 1999. It is now the principle practice-based research network in the state of Michigan.

Evidence-Based Medicine (HM 890, now Epid 899)

Course Co-Director and a designer (1997) of master's level course in evidence-based medicine, outcomes research. A hands-on survey course, provided students the basics in evaluation of evidence, medical measurement, ROC analysis, decision analysis, cost effectiveness analysis, and meta-analysis.

Cultural Diversity Research Experience: Centers of Excellence in Minority Education.

Designed and directed (1994-1998) a mentored summer research experience in minority health. Six to ten medical students work with established faculty investigators in on-going research. In addition to being full-time researchers, students participate in didactic seminars two half-days per week. The heart of the seminars is critical appraisal of student project proposals and published articles key to the students' research. Other topics include biostatistics, use of electronic resources, ethics of research, preparation of research presentations. A formal ten-minute presentation concludes the summer, though students are encouraged to continue with preceptors across the medical school experience.

Social Context of Clinical Decisions (HM 546)

Course Co-Director and a principal designer (1993-1994) of a required four-year sequence in the medical curriculum to teach evaluation of the strength of evidence reported in the medical literature. Videotaped portions of the curriculum have been used in faculty development.

Year 1: Introduction to biostatistics.

Year 2: Introduction - causation, epidemiologic research design, sensitivity/specificity, decision analysis, cost-effectiveness analysis.

Year 3: Evaluation of diagnostic test results, screening, strengths and weaknesses of research designs, continuation of statistical concepts, electronic literature search, meta analysis; students participate in journal club, complete a literature review.

Year 4: Continue journal club, complete a research proposal. Research elective is available.

Human Development (HM 543)

Designed the two-week aging portion of a ten-week (60 hours) course in 1995 for use in year one using a bio-psychosocial approach to human development over the life course.

Clinical Skills (HM 523)

Introduced a module on evaluation of functional status of well elderly patients in 1985. First year medical students complete a functional status evaluation, history and limited physical exam in the homes of community dwelling elders. Module complements age-specific work-up: newborns, adolescents, adult health maintenance visit.
