## TEACHING

**NOTE:** Listed below are my teaching responsibilities for roughly 2011-2021. In any given year for the past ten years this is roughly what my teaching responsibilities have looked like. I have taught an occasional offering of an undergraduate bioethics course, PHL 344. I offer my graduate seminar on health care justice at roughly three-year intervals. This is PHL 870. I last offered this course in the Fall of 2014. In the Winter of 2005, I taught a Freshman Seminar under the title “Pricing Human Life: Ethics and Public Policy.” I have been doing the Freshman Seminar with different topics every year in the spring since 2005. In the Fall of 2006, I taught an advanced special topics bioethics course, PHL 444, “Ethical and Policy Challenges in Genetics and the New Reproductive Technologies.” In the spring of 2017, I taught a new course for a new program, the “Citizen Scholars Program.” The course number was AL 210, “Democratic Deliberation and Health Care Justice.” (4 credits). I have also been teaching a Study Abroad course in London titled “Medical Ethics and Health Policy.” I taught that course for 5-6 weeks each summer from 2005 until 2019.

## MAJOR COMMUNITY CONTRIBUTIONS

I have contributed in numerous small ways to many of the communities of which I have been a part. There are three, however, that I am most proud of.

1. “The Search for Health: Alternatives in Care, Conflicting Rights, Uncertain Responsibilities,” (1976-78), funded by a grant for \$40,000 from the Indiana Committee for the Humanities. I served as a project director and was responsible for organizing a series of six community forums in each of four Indiana communities under the title “Caring: Humanistic Perspectives on Death and Dying.” One of the major outcomes of this project was the creation of the Hospice of St. Joseph County in 1978, the 42<sup>nd</sup> hospice program in the US. This was a community-based hospice that I helped to co-found. I was President of the Board (1980-82) and a member of the Board (1978-85). I negotiated with the CEOs of the four hospitals in South Bend Indiana to secure the funding needed to sustain the hospice program until Medicare funding became available.
2. “Images and Ideals/ Challenges and Choices: Seeking an Agenda for the 80s.” This was a “challenge grant” for \$30,000 awarded by the Indiana Committee for the Humanities. I raised an additional \$30,000 through personally soliciting funding from major corporation in the South Bend community. (1980-83). This project was a novel approach to community leadership development which focused on developing the abilities of emerging community leaders to think through more carefully many of the value conflicts associated with public policy development. There were 24 seminars that were part of each two-year cycle in the project. Thirty emerging community leaders were the primary participants in this project. The discussion in the seminars was around major policy issues at the time: energy and environmental issues, the problems of de-industrialization, health care, education, regulatory issues, all with an emphasis on the value conflicts embedded in these policy issues and how to think them through in a mutually respectful way. This was the beginning of my academic research around rational democratic deliberation.
3. When I came to MSU in 1985, one of the major challenges in health care was developing institutional ethics committees. I had the idea of creating something that came to be called the Medical Ethics Resource Network of Michigan [MERN]. We did a weeklong summer training program for new Ethics Committee members, an annual conference, and case consulting for very difficult cases. I was a founding member and served as President of the Board for two years. MERN existed for the period 1987---2005. MERN dissolved because too many hospitals were hiring their own clinical ethicists to do ethics consultation.

## MAJOR ACADEMIC REPORTS

*Guidelines for Implementation of Crisis Standards of Care and Ethical Allocation of Scarce Medical Resources and Services During Public Health Emergencies in Michigan.* (2021). This is the revised and updated version of the report done ten years earlier, this time in response to the very real and somewhat different ethical challenges posed by COVID [little actually materialized in 2009]. Again, I served as the ethicist for the committee. Again, this was done for the State of Michigan, Department of Health and Human Services.

*Guidelines for Implementation of Crisis Standards of Care and Ethical Allocation of Scarce Medical Resources and Services During Public Health Emergencies in Michigan.* (2011). As the title of the report indicates, I was the ethicist on the committee for addressing these allocation issues. This report was the work of about 25 individuals in medicine and public health. The work on this report began in late 2009 in response to a feared pandemic at the time. This report was done for the State of Michigan, Department of Health and Human Services, Bureau of EMS, Trauma and Preparedness.

The final report of this committee was issued on October 1, 1991 under the title "Michigan Recommendations on HIV-Infected Health Care Workers." It has been circulated to a number of national medical and dental groups who have endorsed it; and it is our hope that this will eventually result in a change of direction by the CDC on this issue. (March- October, 1991). [That change of direction in fact occurred.]

The most recent of those was an on camera interview with Alysia Burgio of WLNS TV regarding passage of AHCA in April of 2017. Most of these media outlets were somewhere in Michigan. Some were quite extensive. I did a three-hour stint on the air for WLNS, Ch. 6 television during Clinton’s visit to Lansing for the summer of 1999, commenting on both the Medicare issues and Patients’ Bill of Rights issues. I am also on the commentator list for Roger Sergel of ABC NEWS, which means I received in the past regular requests for comment on issues related to medical ethics and health care policy. I did at least three interviews with AP reporters. More generally, in any given year since 1985 I have usually had 10-20 contacts with the media during that year, all sorts of brief interviews on some news event of the day.

“Communities of Color and Genetics Policy,” NIH three-year renewal grant for \$1.1 M (Dec. 1998-Dec. 2001); this is a joint project with the School of Public Health at the University of Michigan and Tuskegee University; U of M is the lead institution. Our share of this grant is about \$150K. This grant is under the auspices of the ELSI program at NIH (Ethical, Legal, and Social Implications of the Human Genome Project). It is a follow-up to our original NIH project “Genome Technology and Reproduction: Values and Public Policy” (1995-98) also funded at about \$1.1 M. I serve as a co-principal investigator for this project with primary responsibility for the community dialogue phase of the project. I am responsible for developing the leaders= guides we use as an agenda for each community dialogue, training the dialogue facilitators and dialogue observers, meeting with community groups to assist in recruiting participants, analyzing the results of the dialogue process and then presenting those results at assorted conferences and in peer-reviewed journals. There have been a total of about 90 community dialogue sessions, six at each of fifteen community sites. Most of those dialogue sessions occurred during calendar 2000.

"Just Caring: Justice, Health Care, and the Good Society."  
(1990-93) The Center for Ethics and Humanities in the Life Sciences received a \$15,000 AULEG seed grant [All University Life-Long Education Grant] to support the planning phase of this project, including the resources needed to secure an additional project funding. This will be a statewide project that will create community forums in which issues of justice regarding health care policy can be comprehensively addressed. This project is fully described in a paper with the same title that was produced for the Governor's Task Force on Access to Health Care. During 1992-93 I secured more than

\$30,000 in supplementary funding for the "Just Caring" project from various community foundations, businesses, the Mercy Corporation, Blue Cross/Blue Shield, etc.

"Pricing Human Life: Moral and Public Policy Dilemmas." This was a pilot project in Flint, Michigan. It was similar in terms of type of issues to the Goshen project, but it involved only six seminars in the spring of 1986. Flint is one of the community campuses of the medical school. This project was supported by a grant from the Michigan Council for the Humanities.

"Just Caring: Justice, Health Care, and the Good Society."

(1985-87) A grant from the Indiana Committee for the Humanities for \$16,500. This project was sponsored by the Ethics Committee of Goshen General Hospital. It involved 12 seminars during 1986 and 10 community discussions on a range of issues connected with ethics, economics, and healthcare policy. The project was intended to model how a coherent, complex, extended community conversation on moral and policy issues can be developed and sustained. I directed each seminar, wrote 12 newspaper articles, and developed other resource materials.

"Images and Ideals/ Challenges and Choices: Seeking an Agenda for the 80s." This was a "challenge grant" for \$30,000 awarded by the Indiana Committee for the Humanities. I raised an additional \$30,000. (1980-83). This project was a novel approach to community leadership development which focused on developing the abilities of emerging community leaders to think through more carefully many of the value conflicts associated with public policy development. There were 24 seminars that were part of each two-year cycle in the project.

"The Search for Health: Alternatives in Care, Conflicting Rights, Uncertain Responsibilities," (1976-78), funded by a grant for \$40,000 from the Indiana Committee for the Humanities. I served as a project director and was responsible for organizing a series of six community forums in each of four Indiana communities under the title "Caring: Humanistic Perspectives on Death and Dying."

"Preparing for the 80s: Workshops for Public Officials," (1979-80), grant for \$26,000 awarded by the Indiana Commission for Higher Education. I served as project director after writing the grant and designing the project.

"Social Service Needs Assessment: A Problem Priorities Approach," a grant for \$10,000 from the United way of Elkhart County (1984) to assist their Board in developing a better approach to determining their funding priorities. [Note: This grant, and the three above that, were awarded to the School of Public and Environmental Affairs at Indiana University-South Bend, where I was a faculty member.]
